Description

On the above date and time, [REDACTED] called for assistance in Cypress Unit to C pod. Upon entering the unit [REDACTED] informed us that juveniles [REDACTED] and [REDACTED] had picked [REDACTED] off the floor and into the air. [REDACTED] and I entered C pod and observed both juveniles running around the pod with their shirts off. We began to counsel and encourage both juveniles to calm but they continued to be irate. They continued to run around the pod, they also took [REDACTED] radio and begin yelling gross profanity across the radio for all to hear. We then tried to retrieve the radio from the juveniles as they continued to run around the pod. They then begin to threaten to assault us if we touched them. At this time, the juveniles begin taunting [REDACTED] acting like they were going to hit him as he repeatedly jumped backwards away from them. They then pushed [REDACTED] in the chest so hard, he flew backwards in the air, sliding on his butt and back. [REDACTED] did manage to get back up and juveniles [REDACTED] and [REDACTED] continue to taunt [REDACTED] and I continued to try to calm them down. After running around the pod, juveniles [REDACTED] and [REDACTED] ran up to [REDACTED] and collectively punched [REDACTED] in the face and head several times and continued to run around the pod. At this point the remainder of the juveniles on the pod were all standing in their door ways watching the entire incident. [REDACTED] then went and stood in the front door way trying to get off the pod. While he was waiting for the door to open, both juveniles ran up to him and begin to beat him again, punching him multiple times in the face and head; and then ran around the pod some more. [REDACTED] continued to stand by the door waiting for it to open. As juvenile [REDACTED] and [REDACTED] continued to run around the pod, they headed back towards [REDACTED] again. Both juveniles begin to punch [REDACTED] the face again, I placed myself between [REDACTED] and juvenile [REDACTED]. At this time juvenile [REDACTED] look me in my eyes and began to punch me in the face while I was shielding [REDACTED] creating space for him to exit the pod. After [REDACTED] exited the pod, I secured the door behind him as juvenile [REDACTED] and [REDACTED] continued to run around the pod. **DUE TO THE CONSISTENT RELENTLESS AGGRESSIVE BEHAVIOR DISPLAYED by the BRRC juvenile population that goes unchecked, I directed [REDACTED] to exit the pod completely with me due to uncertainty that the other juveniles would collectively assault us both.** I would like to press charges against juvenile [REDACTED] for assault on staff. [REDACTED] called [REDACTED] for [REDACTED] and [REDACTED] called [REDACTED] for me. End of Report.
